# License agreement

This is a license agreement between ALEXANDER BAUTZ / SPJSBLOG - referred to below as SPJSBlog, and the LICENSEE.

This agreement regulates the use of the Modern Dynamic forms for SharePoint - referred to below as DFFS.

When you buy this software, you accept this license agreement without further written consent.

## Owner rights

You have bought the rights to USE DFFS, but the legal owner is SPJSBlog.

## Your rights to use the product

When you purchase DFFS you can use it for one year. From the second year you must have a MAINTENANCE AGREEMENT to continue using DFFS. The price of the MAINTENANCE AGREEMENT is 20% or the original license cost. The MAINTENANCE AGREEMENT gives you access to updates and support.

You cannot SUBLICENSE or redistribute DFFS in any way unless you have a written OEM license that states otherwise.

You have the right to USE DFFS to the extent determined by the license type you have purchased – see specification below.

## License types

### Site Collection license

This license is bound to ONE SINGLE SITE COLLECTION by a challenge response routine. When it has been first associated with a SITE COLLECTON, it cannot be transferred to another SITE COLLECTON without deactivating it in the original SITE COLLECTON first.

### Company or Department license

This license lets you use DFFS in as many site collections as you like within the company or division you have licensed DFFS to.

### Enterprise license

You can use DFFS in as many site collections as you like throughout your entire corporation.

### Tenant license

You can use DFFS in all lists and libraries in the TENANT.

### Developer license

A developer license can be used for development purposes but is not valid for production purposes.

### OEM license agreements

This will give you the right to INCLUDE DFFS in your own software package and redistribute it as a part or your product(s).

This requires that you use DFFS in a product that adds significant functionality, and you cannot simply redistribute DFFS as-is.

The details regarding the OEM agreement (payment, support, and other arrangements) must be covered in a separate OEM agreement between SPJSBlog and the LICENSEE.

## Upgrades

When you buy a license and have an active MAINTENANCE AGREEMENT, you have access to all MINOR and MAJOR versions of the software. Updates are performed by the LICENSEE by downloading the new version of the software and uploading it to the app catalog in the site collection or tenant.

## Data policy

Other than the initial manual challenge-response routine for validating the license, DFFS will NEVER "call home" to collect information or log activity.

All data entered in forms enhanced with DFFS is the property of the LICENSEE and no data is sent out of the tenant.

## Documentation

SPJSBlog will provide updated user documentation that reflects the functionality in the PRODUCTION version of DFFS on the SPJSWorks.com website.

This documentation will NOT cover all variations of custom code you can use in the Custom JS and Custom CSS area in DFFS.

## Support

When buying DFFS, the LICENSEE agrees that all support (unless there is a written agreement that states otherwise) will be provided through the SUPPORT FORUM at <http://spjsblog.com/forums/forum/dynamic-forms-for-sharepoint/>

Support by EMAIL, TELEPHONE or TEAMS shall be initiated from SPJSBlog. Extensive support that is not related to bugs in DFFS may be charged after a pre-consent from the LICENSEE.

## Support for Partners

Partners have further privileges regarding support and can use EMAIL for specific issues that are not of general interest to the community. For general issues, the forum is still first line.

## Bugfixes

When bugs are fixed and a new version of the software is released, the LICENSEE must update the software as described under UPGRADES above.

## New features and ideas

In case a LICENSEE suggests new features to DFFS that are developed by SPJSBlog.com, these will be covered by the existing license agreement.

## Discretion, loyalty, and mutual information

This is covered in a separate OEM agreement for each LICENSEE.

## Breach of contract

This is covered in a separate OEM agreement for each LICENSEE.

## Transfer of rights and obligations under the agreement

Unless otherwise agreed in a written contract, both parties have the rights to transfer the rights and obligations covered by this license agreement to a third party.

## Duration / Termination

This general license agreement will be effective until the LICENSEE stops using DFFS.

OEM license agreements may have other terms.

## Enforcement of rights

The LICENSEE is responsible for preventing unauthorized use of the product - for example by trying to bypass the license validation routine. In cases the LICENSEE detects this kind of activity, SPJSBlog must be notified immediately.

SPJSBlog is responsible for providing documentation and giving support in case there are legal disputes related to DFFS.

## Retirement / phasing out DFFS

DFFS is created with 100% client-side code and will not modify any parts of the form or list / document library.

In case the LICENSEE chooses to stop using DFFS, the solution must be removed from the APP catalog. When this is done, the form will be a 100% original SharePoint form, and will not have any trace of DFFS.

## Legal disputes

This agreement is subject to Norwegian law. Any dispute arising from the Agreement which is not settled amicably shall be governed by Norwegian law and Norwegian courts.

The liability for the LICENSEE and for SPJSBlog is limited to the value of the contract / the price of the license.
